### If you are missing your tax records, you can request copies from the IRS. This includes:

- Form 1040 (Federal Tax Return individual, joint or head of household)
- W-2 Forms (Wage & Tax Statement from your employer)

## METHOD 1: IRS WEBSITE - www.irs.gov/individuals/get-transcript

#### Request your transcript online for the fastest result.

#### What you need:

If you don't have an existing IRS username or ID.me account, you will need your photo ID ready.

You'll get access to view, print & download your transcript.

## **METHOD 2: REQUEST BY MAIL**

Request your transcript by mail through the IRS website listed in method 1 or by calling the IRS automated phone transcript service at 800-908-9946.

#### What you need:

Your mailing address from your latest tax return

Transcripts arrive in 5-10 days at the address they have on file for you.
